It is not true but false that Genl[.] Curtis did not see or converse with Genl[.] Marmaduke until the following day at Fort Scott--on the contrary Genl[.] Curtis did not see either Genls[.] Marmaduke or Cabell the following day either at Fort Scott or elsewhere--but left that place early the following morning in the pursuit of Price intent upon the demolition of the army of that [MS. illegible]--leaving to his subordinates the custody of the prisoners.
